B-2, and B-3, attached to Resolution No. 2019-065, on the same day the notice was first
published or posted;

WHEREAS, § 7-12-1113, MCA, allows the owner of any property liable to be assessed
to make a written protest against the extent or creation of the District, or both, and any owner
duly noticed was required to submit that protest in writing and deliver it to the Gallatin County
Clerk and Recorder no later than 5:00 p.m. on July 22, 2019;
WHEREAS, protests were filed with the Gallatin County Clerk & Recorder as
of July 22, 2019 at 5:00 p.m.;
WHEREAS, § 7-12-1114, MCA, requires the County Commission, after close of the
protest period, to hear and pass on all protests received;
WHEREAS, the County Commission has reviewed any protests received and finds that
the protests do not meet the threshold requirements at § 7-12-1114(3), MCA, and the County
Commission therefore passes on all protests as insufficient and denied;
Commission dictorore passes on an protests as insufficient and defied,

WHEREAS, notice of the hearing on this Resolution was noticed in Resolution No. 2019-065, the notice of adoption that was published in the Bozeman Daily Chronicle and mailed to each of the property owners, and on the agenda for this hearing as published online and in the Bozeman Daily Chronicle.

NOW, THEREFORE, BE IT RESOLVED as follows:

- 1. The County Commission hereby orders the creation of the District in accordance with Resolution No. 2019-065.
- 2. The County Commission also orders the creation of the Gallatin Valley Tourism Business Board of Trustees in accordance with Resolution No. 2019-065.
- 3. The County Commission directs its staff to immediately advertise for appointment of seven (7) members to the Board of Trustees, who shall all be owners of real property within the District or their assignees.
